

## **Team Hurt Man Rescue**

Mean Time = 5 minutes ~ Dead Time = 7 minutes

**Event Description:** This event will be a 3 man team event with all three contestants participating at the same time and at the same station. The pole will be a 40' class 5, A1.1 with a transformer hung on the back quarter 18" below the neutral, and an equipment mounting bracket mounted below the pole top pin in line with the phase. The manikin will be placed between the transformer brackets on the back side of the pole opposite the neutral. There will be an ox block hanging 8" above the neutral, above the manikin. The line is simulated energized.

### **Basic Outline:**

1. Teams will have a 5 minutes setup time
2. Poles must be sound checked with a hammer
3. Time starts on judges signal
4. At "GO" a team member will go to an assigned judge and call a mayday call using script below
5. No team member may be on a pole or have an extend-o stick extended before start time
6. All tools and equipment must start outside the event circle
7. At "GO" the lineman will bring his tools inside the event circle and adorn the climbing equipment
8. Before the climber attaches to the pole the cutout door must be opened using an extend-o stick (team will need to provide)
9. Climber will then climb up into position to untap the cutout using the shotgun, provided for the event
10. The climber will then move into position to break the ox block and tie the manikin off using three half hitches, tied tightly to the chest
11. The climber must get two clicks of wraps on the ox block
12. The climber will cut the strap at the designated spot to free manikin
13. The manikin will be lowered to the ground in a controlled fashion, once below head height he will be drug outside the event circle
14. The manikin will be placed in a position to perform CPR
15. One groundman will get into position to perform CPR, check for breathing, then get hands in position to do CPR
16. Time will stop when the manikin is outside the circle and paced in position to perform CPR
17. Judging will continue until all tasks are complete and climber reaches the ground
18. The event is simulated hot. This means that the climber will use rubber gloves.
19. The rubber gloves will be in a snapped (or Velcro), closed bag to begin the event
20. Rubber gloves will be put on before ascending the pole

### **Possible Deductions (10 pts)**

1. Either arm of the manakin comes out of the tie made by the climber.
2. Manikin falls freely to the ground.

### **Possible Deductions (2 pts)**

1. Infractions of any rules listed in the General Rules.
2. Failure to read the provided Mayday script within the designated area.

3. Failure to have tool belt, glove bag, or hooks properly positioned before starting event.
4. The climber ascending the pole before the cutout is opened by a groundman.
5. The groundman touching the extendo stick before time begins.
6. Climber ascends pole under victim
7. The climber rescuing the manikin before removing the jumper with the provided shotgun stick.
8. Knife not sheathed or folded. Use of an open tool pouch is not acceptable.
9. Failure to call "head-ache" when dropping the rope or the sheave.
10. Failure to tie the rope tightly around the manikin's chest.
11. Failure to tie the manakin off with three half-hitches.
12. Failure to make 2 clicks of rope on the friction bar of the Ox Block.
13. Failure to cut the safety at the indicated inserts (between buckles).
14. The lineman cutting toward his own body.
15. Failure to lower the manakin in a controlled fashion. The manikin cannot hit the ground hard. (Hitting the ground too hard is the judge's call. It will be based on the question, " Would the impact produce injury to a real victim?")
16. Failure by ground man to simulate initial CPR actions.
17. Lineman climbing down while team member within pole circle.

**Tools and materials provided by teams:**

1. Extend-o stick
2. 8' shotgun
3. Hand tools needed for the task

**MAYDAY Script:**

Groundman: "MayDay, MayDay ... Truck 2033 to the dispatcher ... We have a man down emergency."

Judge: "Dispatch to truck 2033 ... I understand you have a man down emergency."

Groundman: "Truck 2033 ... That is correct. We are located at 1630 Lyndon Farm Ct. and have a man down. We are beginning pole top rescue and need an emergency medical team dispatched."

Judge: "I understand that you are at 1630 Lyndon Farm Ct. and have a man down and need medical assistance."

Groundman: "Truck 2033 ... That is correct, we need immediate medical assistance."

Judge: "Medical assistance is on its way. Over and out."
